




Curator – drag & drop and live preview

#### Edit topics and processes quickly and easily

You can now simply drag and drop content in Curator to display it in the desired order. An integrated preview now helps you when adding, editing and structuring documents.

These functions are rounded off by a modernised look & feel in Curator for a more pleasant user experience.






### Creator – individual authorisation for Creator templates

#### 2025

Now you can easily define who is authorized to access which Creator templates.

You can define authorization groups per template for your users. This makes it possible to authorize individual users for specific functions, such as the use of AI templates. For example, you can only grant other users access to templates for creating e-learning courses and step lists.

This function makes it easy to customize the content creation options with the Creator to the needs or level of knowledge of your users.






Creator – create and edit learning units directly in the browser


Curator – predefined performance support categories for creator templates

Control which documents are displayed to your users in QuickAccess when searching and which they should only see in the context of processes or topics.






Curator – display cyclical processes

### **Performance Support**

Creator – provide copyable texts

#### 2025

#### Define copyable texts that can be pasted from the clipboard.

Text content can now be easily provided as a copy template - with just one click, it is copied directly to the clipboard. This not only saves your users time, especially with frequently used content, but also avoids errors by copying the exact content.

This can be helpful, for example, when it comes to unique identifiers and reference codes that users need to use frequently. Instead of typing these codes manually in the target application, users can simply copy and paste them.

This function is now available in all text-based Creator templates.





### Creator – create buttons


Provide your users with additional functions at the click of a button.

Choose between various functions, such as copy text or image, set link or mailto link.

Use "Link" to link internal or external content in an attractive way for your users.

"Copy image/text" helps you to provide your users with content such as reference numbers or an email signature with image for easy copying to the clipboard.

With "Mailto Link" it is possible to create a predefined e-mail template for your users, which can be called up and sent using the button. Of course, you can also choose the colour, text and icon, as well as the size and position of the button.





Creator – create interactive images

# Explain details in the context of a larger context simply and clearly with interactive images.

You can choose between a linear sequence or free navigation via hotspots. Simply select the image section you want to describe in the original image and add the descriptive text.

Users can navigate directly to the description with one click via the hotspots (red in the example on the right).For example, business units can be displayed in detail, but also in the context of a larger organization.






Producer – blacken sensitive content

#### 2025

Make personal and sensitive data in your content unrecognizable.

Blacken allows you to ensure that sensitive information cannot be read by other users. As the author, however, you can also undo or adjust the blackening in your document.

This function is useful if, for example, you want to redact personal data such as names or addresses for your users.





QuickAccess – show related content

Show your users where documents are used in the search results.

Your users can jump directly to related processes, topics and courses and save valuable time when searching for information.

Content can now be opened even more intuitively using the entire click area instead of just the icon.

### QuickAccess - optimized visualization of processes and topics



QuickAccess / WebAccess - uniform hyperlinking

Hyperlinks are now consistently created in https format throughout the tts performance suite. You will find the corresponding buttons in the new burger menu in QuickAccess.

Hyperlinks to QuickAccess content will automatically open in QuickAccess via redirect after one-time activation. Accessing content in WebAccess remains unchanged.

Employees can now conveniently access the desired content using a smartphone, laptop, PC or handheld device.

Standard operation procedures (SOPs) and destination-specific regulations

#### **Customer situation and use case**

The customer implemented CargoWise One in October 2021 to support personnel in shipment planning, execution, and tracking.

Employees must enter key shipment details, adhering to customer-specific Standard Operating Procedures (SOPs), such as uploading documents to designated portals or scheduling departures in advance.

Additionally, destination-specific regulations must be followed, e.g. certain documents may need to be submitted to customs before arrival.



#### Starting point

During the initial usage of tts performance suite, they used Performance Support categories to structure nearly 150 guides.

This high number complicated the search for relevant content.





Pregnancy notification and risk assessment

#### **Customer situation and use case**

Some HR processes tend to be extensive, complex, errorprone, and mapped in heterogeneous IT systems. Our customer wanted to develop an efficient solution to support employees in complying with complex HR processes.

A particularly challenging example is the process for reporting a pregnancy and the subsequent risk assessment.



Starting point

The current resources: A 16-page PDF with little structure and clarity. Important elements such as clearly defined roles, responsibilities and tasks were insufficiently elaborated.







# **Production in opencast mining**

Carrying out safety inspections and maintenance for crawler loaders

#### **Customer situation and use case**

To ensure safe operation of heavy-duty equipment in opencast mining, our customer developed internal training programs.

However, retirement of experienced colleagues, inadequate driver manuals and incomplete onboarding led to improper operation, causing increased wear and machine downtime.

To improve safety and efficiency, they developed Business Guidance for various machines.



# Production in opencast mining

#### Starting point

The internal training programs include a theory phase with webbased training (WBTs), classroom instruction and an extensive field training phase for each machinery.

The retirement of experienced colleagues, inadequate instruction of new employees and poorly suited driver manuals caused an increase in wear and tear and machine downtime.

Determining the correct tax code

#### **Customer situation and use case**

The customer is processing invoices in SAP S/4HANA, where the tax code must be manually entered to ensure correct VAT offsetting.

Despite extensive training and documentation, the error rate remains high due to the complexity of applicable tax regulations, especially when multiple countries are involved.

This creates a risk of incorrect tax filings and delays in payments.






